#### 1. Background

Khadi sub-sector is largest non-farm sector in India employing 11.07 lakh artisans through 1950 KIs spread across the country (KVIC Annual Report, 2015-16). About 80% of the artisans are women. The sector has registered production of INR 1065.60 crore and sales of INR 1510.00 crore in 2015-16. As compared to 2014-15, the production in 2015-16 registered an increase of 21% and sales of 29%. Khadi and Village Industries Commission (KVIC), the nodal body for promoting the sector implements 13 different schemes for the sector, including schemes for welfare of artisans.

India has significant opportunities for Khadi, by repositioning it and linking Khadi to the consumers' perception with its environment friendly, socially conscious and fair wage characteristics. In the current scenario, lack of consumer centric approach coupled with low consumer awareness has led many players taking advantage of non-genuine Khadi in the market.

Hence, with an objective to create a distinct identity of genuine Khadi, the Khadi Reform and Development Programme (KRDP) envisaged development of Khadi Mark which will guarantee the genuineness and quality of Khadi i.e. hand spun and hand woven nature, containing natural fibre (cotton/wool/silk) of Khadi cloth. As the

promoter and guardian of Khadi Mark, KVIC will monitor, verify and enforce the genuineness of products being sold as Khadi.

The following are the key objectives of Khadi Mark:

- Guarantee genuineness of Khadi and Khadi products produced in India - "Hand Spun, Hand Woven and Natural Fibre"
- Establish an unique identity for Khadi
- Improved customer awareness
- Increase popularity of Khadi

#### 1.1. Significance of Khadi Mark

Khadi Mark signifies that the Khadi product is made of natural fibre i.e. cotton, wool and silk through the process

of hand spinning and hand weaving. In this regard, Khadi Mark Regulations 2013, published in the Gazette of India dated July 22, 2013, No. 3212 GI/2013, empowers KVIC to provide Khadi Mark by laying down standards of assurance and by authorizing the use of Khadi Mark.

With the Khadi Mark Regulations 2013, in force, no textile shall be sold or otherwise traded by any person or institution as Khadi or Khadi product in any form or manner without it bearing a Khadi Mark tag or label issued by the Commission under these regulations. Also, no institution or person engaged in the business of sale of Khadi or Khadi products shall procure Khadi or Khadi products unless such Khadi or Khadi product bears a Khadi Mark tag or label issued under these regulations. Khadi Mark tags or woven labels will not be applicable to Polyvastra and its products.

## 1.2. Implementation of Khadi Mark

The Khadi Mark Regulation and Khadi Mark Procedural Protocol were notified during 2013, but the implementation of Khadi Mark at KI level has been initiated in 2014-15. The following activities are being undertaken for implementation of Khadi Mark:

### **Box 1: Implementation of Khadi Mark**

So far 2077 Khadi Mark Certificates have been issued by KVIC. Implementation initiated across all six zones with facilitation support of state offices and support of large KIs for production and distribution of labels and stickers.



- The Central Khadi Mark Committee (CKMC) and Zonal Khadi Mark Committee (ZKMC) were constituted in 2013-14 at respective levels in accordance with the provisions of Khadi Mark Regulations, 2013.
- Khadi Mark Procedural Protocol, 2013, samples of labels and stickers and specifications for production of labels and stickers were disseminated by KVIC to all SO and DO. The SO / DO further disseminated the same to KIs during 2013-14.
- In order to raise awareness regarding Khadi Mark and orient KIs for implementation, 14 zonal workshops were conducted by KVIC with support of consultants in 2014 and 2015 covering about 88 KIs, 560 participants. The State and Divisional Officers were also orientated for implementation. The implementation of Khadi Mark has received an impetus after the workshops.
- Currently, all 1950 working KIs have been issued Khadi Mark Certificates. Applications have been received from private sector entities such as Raymonds, Fab India and Arvind Mills.
   Raymonds has been issued Khadi Mark Certificate other applications are being processed by KVIC Central Office
- As per Khadi Mark Regulation, Private entities and individuals have to undergo inspection by accredited
  agency for compliance and testing of Khadi samples in laboratories set up by KVIC or Government Testing
  Laboratories. For this purpose, National Institute of Textile Research Association (NITTRA) has
  been appointed as accredited agency for inspection and providing Inspection report. The entities or
  individuals would be issued Khadi Mark certification if the report is satisfactory. The process is has been
  initiated.

## 1.3. Need for Spot Audits

It is essential to verify if the Khadi Mark is implemented as per the guidelines at institutional level and in Direct Sales Outlets (DSOs) of the KVIC. For this purpose, random Spot Audits (i.e. verification of compliance of Khadi Mark at institutional level) need to be conducted.

Under KRDP, there is a tranche condition mentioned regarding conducting random spot audits. This random spot audit has to be

conducted ONLY for checking the compliance regarding implementation of Khadi Mark by the Khadi Institutions which have been given valid Khadi Mark registration certificate by the Central Khadi Mark Committee (CKMC). The purpose of the audit is only to see if these KIs are implementing Khadi Mark as per the procedure protocol and to facilitate them in the implementation process. It is also to understand the issues and roadblocks being faced by the KIs in the implementation of the Khadi Mark. This spot audit is not concerned for Khadi Institutions who are getting direct reform assistance under (KRDP).

# 2. Approach and Methodology for Spot Audits

The Khadi Mark Compliance Verification (Spot Audit) was undertaken to verify implementation of Khadi Mark as per the guidelines issued under Khadi Mark Regulation, 2013 and Khadi Mark Procedural Protocol, 2013. The parameters for audit and methodology are further explained in detail.

### 2.1. Parameters for Spot Audit

The Spot Audit comprised of verification of compliance of sample KIs for implementation of Khadi Mark vis-à-vis guidelines. Emphasis was on appropriate usage, promotion of Khadi Mark and systematic implementation. The process comprised of physical verification of the following:

Availability of Khadi Mark Certificate

- Production / Procurement of Khadi Mark and Stickers
- Maintenance of record of Khadi Mark labels and stickers
- Affixing of labels and stickers on products and stamping of cloth as per guideline
- Initiatives of KIs for promotion of Khadi Mark
- Challenges in implementation
- Suggestions for strengthening implementation

#### 2.2. Selection of KIs for Spot Audit

It is expected that all the 2077 KIs which have been issued Khadi Mark Certificates are actively engaged in production and / or sale of Khadi. 240 KIs were selected across India from states with maximum concentration of KIs.

For the purpose of selection, the list of certified KIs was prepared at the SO / DO level and 10% of KIs were randomly selected for conducting spot audits. However, some of the states (Tamil Nadu, West Bengal, Kerala) chose to cover more KIs for the purpose of monitoring implementation of Khadi Mark in their respective states. Hence, the distribution of spot audit reports received was skewed towards East and South region.

The zone-wise distribution of the sample and actual audits conducted are as follows:

### 2.3. Process of Spot Audit

Systematic process was adopted for conduct of spot audit. The process is described as under:

- Preparation and dissemination of guidelines: The guidelines for Spot Audit and format for recording observations and findings were prepared by KVIC Central Office. The guidelines and formats were disseminated to all SO / DO through mail on 11th May 2016.
- Orientation of SO / DO through Video Conferencing: In addition to dissemination of guidelines, the Dy.CEO, KVIC provided an orientation




Figure 1 Process of conducting Spot Audit

to the SO / DO representatives regarding significance and process of conducting spot audits. The process of Spot Audit would be continuous process followed by KVIC to keep a check on the implementation of Khadi Mark guidelines.

- **Deputation of Spot Audit Teams at SO / DO level:** A two-member was constituted at respective SOs / DOs. Atleast one of the members of the team had experience in Khadi sub-sector.
- **Field visits for physical verification:** Field visits were conducted by Spot Audit Team simultaneously in all six zones. The team conducted a physical verification of the compliance of the Khadi Mark on the identified parameters as per the guidelines. Visits were made to the administrative offices, production centres and sales outlets of the KIs. Observations were recorded in the formats disseminated by KVIC.
- **Compilation and analysis of data:** The data of Spot Audits was sent to KVIC Central Office, where it was compiled, cleaned and analysed in excel by the consultants.


**Preparation of report:** A detailed report of findings of Spot Audits was prepared for audit of 240 KIs. The report was finalized after review by KVIC. The findings will be further disseminated to the SO / DO for implementing recommendations applicable at the field level.

# 3. Findings of Spot Audits

The Khadi Mark Spot Audits were conducted in 12 states in the five zones, and a total of 240 KIs, both DRA and non-DRA have been covered. The list of KIs audited has been provided in Annexure 2. The outcomes of the spot audits have been described below:

### 3.1. Compliance for Khadi Mark

- 138 KIs (58% of the total KIs) are using Khadi Mark as per guidelines, i.e. the labels are prepared for products priced Rs.50 and above and stickers are being affixed for products priced below Rs.50. The labels have the Khadi Mark logo as per specifications issued by KVIC. The registration number of the KI is also provided. Seals / Stamps are used for running cloth.
- 124 KIs (52% of the total KIs) have maintained some format/register for recording the usage of Khadi Mark labels while the others have no such records maintained.



• Among the 132 KIs, total 6.29 lakh labels have been produced, average being 4764 labels per KI.

#### 3.2. Usage of Khadi Mark on products

- Most of the KIs have been using the **Khadi Mark labels on Sarees**, **Readymade Garments**, **Than**, **Bed & Pillow Covers**, **Towels**, **Napkin**, etc.
- 112 KIs (81% of the total KIs using Khadi Mark labels) also use Khadi Mark labels on Khadi products procured from other KIs for sales at sales outlets while the others do not affix any labels on the products of other KIs.

#### 3.3. Acceptance of Khadi Mark among customers

- Of the KIs using Khadi Mark labels, nearly **48**% of the KIs have **reported that customers positively** accepted the Khadi Mark labels ranging from high to medium.
- **59%** of the KIs using the Khadi Mark labels have also reported that customers have also **enquired about significance** of the use of the Khadi Mark and the meaning of the logo.

#### 3.4. Challenges faced in the use of Khadi Mark

- Nearly 17% of the KIs which have been using Khadi Mark labels have reported that they face some issues in usage of Khadi Mark labels and stamps. Some of the key issues reported are:
  - o The **size of the stamp/seal is too big and thus becomes unattractive** for the customers. The customers have raised objection to the seal as it spoils the original look, specifically in white colored towels and dhotis. The border on the stamp also adds to the seal size which spoils the cloth on the sides.
  - The seal doesn't come out clearly on the cloth, specifically colored cloths/dhotis/towels;
     and hence the purpose of the seal is served to a limited extent.
  - o **Stitching of labels on thick cloth** like bedsheets, carpets, *thans* and towels along with expensive material like silk sarees, **has also been reported to be very difficult**.

#### Box 3: Usage of Khadi Mark Labels and Stickers

Labels used on products priced Rs. 50 and above:

- · Saree and dhoti
- Readymade garments for men, women and children
- Towels and bedsheets
- Upholstery

Stickers used on products prices below Rs. 50

- Handkerchiefs
- Cotton napkins
- Cushion covers
- Accessories such as small purses



# 4. Recommendations for strengthening implementation of Khadi Mark

Based on the findings of spot audits and suggestions of KIs, SOs, and DOs, the following recommendations are made for further strengthening of Khadi Mark implementation:

- In some cases Khadi Institutions have started using Stickers/Paper tags as recommended in the Spot Audit Report of July 2016. Stamps and seals are still used on cloth and towels, which need to be replaced by paper tags to maintain the original look and color.
- **Stringent measures** and continuous monitoring needs to continue, to oversee proper enforcement of Khadi Mark regulation and application by the private traders. Action may be taken against the non-compliant parties.
- The state/central office may provide for wider publicity through **advertisements** in the **local news channels**, **regional newspapers and the radio channels** to promote the Khadi Mark as being done by Ministry of Textiles for Handloom Mark/ Silk Mark.
