1. Background

Khadi and village industry (KVI) subsector contributes significantly to the non-farm sector in India. At present, there are over 2000 Khadi Institutions (KIs) in India. The Khadi Reform Development Programme (KRDP) iniatied by Ministry of Micro Small and Medium Enterprises (MoMSME) with support from Asian Development Bank (ADB) envisages to strengthen the sector through sectoral reforms.

Among various other interventions under KRDP, Direct Reform Assistance (DRA) is proposed for 400 Khadi Institutions (KIs) in the form of Infrastructure Upgradation, Marketing, Improving Production Efficiency, Improving quality, Capacity Building, Institutionalising Management Information System, etc. For selection of the eligible KIs with good potential to implement reforms, assessing feasibility and viability of interventions, management audit of selected/identified KIs in was proposed in multiple phases. Audits of 180 KIs have been completed in Tranche 2.

<u>Under Tranche 3, 220 KIs are to be provided support under DRA and the report presents the findings</u> of audit conducted for these 220 KIs .

The process and methodology for conducting the audits and key findings of audits conducted for total 220 KIs across 27 State offices and 6 zones are presented in the report.

2. Methodology

Detailed guidelines for conducting audit and templates for compiling data of Khadi Institutions were developed by the KVIC and Consultants based on five major parameters. These included Infrastructure, Financial Performance, Management and Human Resources, Marketing and Institutional Governance. Apart from this, for each of the parameters, risk areas were identified. The Audit Firms were expected to assess the risk areas objectively and report the same. The methodology is further elaborated.

2.1. Parameters for assessment

The parameters identified and method of assessment and

- 1. **Assessing Infrastructure**: Reviewing the adequacy, appropriateness and capacity of the infrastructure of the Khadi Institution.
- 2. **Financial Performance:** Reviewing the financial performance of the Khadi institution vis-à-vis compliance with rules and regulations, judging the reliability and integrity of the financial information and assessing the existence and effectiveness of the key internal controls that manage finance related issues.
- 3. **Review of Management and Human Resources**: Reviewing the management aspects of the Khadi Institution and assessing the social audit perspectives with regard to the human resources such as humane working conditions, respect for environment, timely payment of wages and provident fund.
- 4. **Review of Marketing of Khadi**: Reviewing the marketing arrangements for Khadi and the mechanism in place for promotion of Khadi. The potential of the Khadi Institution in terms of absorbing the 'marketing' related reforms and the capacity and capability of the Institution will be determined.
- 5. **Institutional Governance:** Since the reforms aim at making the artisans a part of the reform activities; the review will address governance issues and the willingness of the existing management to mainstream the artisans, women and socially backward communities. The review will also track the past performance in terms of internalizing the several schemes of the KVIC and the Government of India and the extent of benefits from such schemes passed on to the artisans.

As part of the audit, risk areas were identified and audit plan was prepared based on risk assessment and information available. Based on the analysis of KIs on above parameters, the KI had to be rated on a scale of 1 to 10 on each parameter as well as overall performance. The ratings are as follows:

- a) Rating 1-3 : Average
- b) Rating 4-5 : Good
- c) Rating 6-8 : Very Good
- d) Rating 9-10: Excellent

2.2. Conducting audit

The audits were conducted on-site by the CAG empanelled audit firms. The process involved the following:

- Review based on working papers and financial statements for previous three financial years (as applicable)
- Physical verification of implements and raw material at production centre
- Physical verification of inventory at godowns and sales outlets
- Review of situation of overall infrastructure through visit

• Discussion with the office bearers regarding overall performance and challenges.

Relevant data was compiled in specific templates. Data analysis was conducted by the firms based on above parameters and risk areas identified. Thereafter, rating was assigned to the audited KIs followed by preparation of Draft Management Audit Reports.

2.3. Preparation and finalization of Audit Reports

The auditors provided draft management audit reports to KVIC. These were reviewed by the consultants with respect to the ratings and justification provided by the audit firms. Wherever deemed necessary, further information was sought from the auditors and inputs were provided to further improve the quality of the reports. On the basis of these inputs, the auditors modified and submitted the final audit reports. The final audit reports of 220 KIs were analysed by the consultants.

3. Key findings

The reports submitted by the audit firms were reviewed by the PwC. Key findings and observations of the auditors and analysis of performance of KIs in management audit by PwC are elaborated hereinafter.

3.1. Infrastructure

Overall situation of infrastructure in majority KIs is observed to be in a good condition with 75% of the KIs scoring 6 and above marks (figure 1). It was observed that adequate space is available for production, storage and administrative activities. Majority KIs own the building and premises. Some KIs upgraded their production infrastructure through the 'Workshed Scheme'. The space available in the production center is sufficient for the production related activities and majority KIs under the

study are able to utilize the infrastructure at optimum level.

With regards to infrastructure facilities, the KIs in East are the best performers with an average rating of 7.2, closely followed by South with an average rating of 6.8.

Maintenance of charkhas and looms was an issue across some of the KIs under study. Some KIs have set up worksheds for the artisans below poverty line and majority of the KIs have their own sales outlets.

The godowns maintained by KIs have adequate storage capacity. However, requisite safety measures are not complied with. The inventory management practices are also not in accordance with the industry norms even in KIs being rated as "Very Good". Majority of KIs maintain stock record at the central KI office and these stock records are not available at godowns. Separate records for obsolete stock are not maintained and delays occur in disposing such stock by giving additional rebate/discount.

3.2. Financial performance


The audit reports reflected that most of the KIs are able to manage their funds efficiently (figure 2). Majority of the KIs manage Artisan Welfare Fund according to the norms. In case of KIs with rating below 5, difficulties are faced in cash flow management and shortage of working capital is faced.

Records have been maintained manually in majority of the KIs. Return on Assets and Return on Equity are very low for KIs and are even negative for many KIs. Debt equity ratio is on higher side which indicates long term solvency issues for the KIs. Thus, the KIs require interventions for financial strengthening.

It was also observed by the auditors that across KIs the wages and salaries are paid according to KVIC norms. Bank accounts have been opened for the artisans and pass books are also maintained.

It was observed that KIs are slow in adopting financial reforms due to dependency on subsidies, low levels of awareness and lack of technical competencies. Misconceptions regarding earning surplus prevail (for eg- most KIs believe that KVI sub-sector being a non-profit sector should not follow

market practices for profitability, customers should not be required to pay high prices etc). There is limited clarity about implementing financial reforms, and the KIs lack competencies for independent undertaking of activities such as market research, product development etc. Therefore, there is a need for consistent sensitization of the KIs to clarify the concepts in financial reforms and provide technical support for introducing market linked pricing and adopting benefit chart. The field officers have a key role to play in this regard since they are in regular contact with the KIs through field visits, trainings etc.


With regards to financial performance, the KIs in South are the best performers with an average rating of 7.0, closely followed by East with an average rating of 6.8.

3.3. Management and Human Resources

Majority KIs (52%) achieved 'Very Good' in management practices as per the reports (figure 3). Around 40% of the KIs were rated 5 or below on management and human resources parameter. Primary reason being, the KIs do not have any specific recruitment policy and appraisal system. Recruitments have not taken place in last 3 years in most of the KIs.

The audit reports have also captured highlights of auditor's interaction with KIs during audit. The KIs responded that there is good demand for the Khadi products but they are not able to meet the demand due to

shortage of artisans. Also, periodic trainings have not been conducted for skill upgradation, especially related to marketing. It was also found that the trainings for artisans and office bearers need to be more diversified and more areas related to product design and development, marketing, financial management, and trainings related to implementation of schemes and programmes need to be introduced




There is dissatisfaction among artisans and staff regarding income which is stated by the KIs as main

reason for shortage of human resources. Majority of artisans also work under MNREGA since the wages under MNREGA are higher.

With regards to financial performance, the KIs in South are the best performers with an average rating of 7.0.

3.4. Marketing of Khadi

Majority KIs have been rated 6-8 in marketing parameter (figure 4). The performance can be attributed to adoption of modern designs by the KIs, use of diversified product mix to meet the changing demand, renovated sales outlets as well as innovations in product packaging. The reports also indicate that the KIs mainly rely on sales through their own outlets and exhibitions / trade fairs. Specific marketing strategy or efforts for publicity were not evident. Dependence on KVIC was observed for promotional activities in all the KIs. Majority of KIs own sales outlets. The KIs which were rated *Very Good* in this parameter have consistently met the sales target, while those with average ratings had lower sales.

The KIs have started using Khadi Mark and some of the KIs are actively providing information about the importance of Khadi Mark to its customers to the extent possible. While some of the KIs are doing


innovations in production and also leveraging strengths of e-commerce platforms for marketing of KVI products, the focus of majority KIs is on khadi production; very few KIs have taken initiatives/innovations for introducing new products.

With regards to marketing, the KIs in South are the best performers with an average rating of 7.0.

3.5. Institutional Governance

The audit of KIs on parameter of Institutional Governance indicates that majority of KIs comply with

the institutional governance norms (figure 5). All have representation of artisans in the management committee. However, majority of KIs have reservations regarding increasing number of artisans to more than two to three artisans in the management committee and any decision or resolution to increase the number of artisans in the management committee has not been observed by auditors. Meetings were also observed to be held regularly in accordance with the bylaws in KIs. Figure 3: Institutional Governance



In the opinion of auditors, there is adequate participation of artisans in the GOI sponsored social security schemes such as Janashree Bima Yojana (JBY) and Artisans Welfare Fund is managed and operated for the benefit of the artisans.

In case of good performing KIs, appropriate safety and hygienic practices were observed and facilities like safe drinking water and toilets were also provided at production centers. There was no evidence of child labour in any of the KIs. Particular initiatives for artisan welfare in addition to the activities mentioned above, e.g. SHGs, awareness sessions, etc were not evident in any of the KIs as indicated in the reports.

With regards to marketing, the KIs in South are the best performers with an average rating of 6.9.




3.6. Overall ratings across KIs and across zones

At an overall level, the following can be concluded based on the findings of the management audit:

all the KIs (i.e. 220) have been assigned a rating of 4 and above, indicating that these are eligible for

assistance under DRA (figure 6). 2. On overall analysis of the distribution of score across audited KIs, Median score for 220 KIs is 6.3,

2. On overall analysis of the distribution of score across audited KIs, Median score for 220 KIs is 6.3, indicating that overall performance of the audited KIs is very good. It is found that maximum number of KIs (105, i.e. 58%) have been rated in the range of 6-8.

The distribution depicts that majority KIs have been rated in the range of 4-8, with a few outliers on the higher side.

3. With regards to the regional performance of the KIs, KIs in the South zone are the best performers, closely followed by KIs in the East zone (figure 8). This may be attributed to the innovations in marketing and production activities in the South zone. Many of the KIs in South have initiated online marketing as well as implementation of linked market prices. This has contributed to improved performance.

4. Recommendations

The audit firms have made several recommendations. These are as follows:

- Production capacity of KIs have to be improved and should be utilized to maximum capacity. The infrastructure should be upgraded to include facilities for the artisans in the production centers and worksheds. The safe storage practices should also be promoted.
- Capacity building for skill upgradation, product development and IT has been recommended. Participation of artisans in the governing body, including women artisans, need to be encouraged further.
- Computerization of sales outlets and usage of IT for maintaining accounts and MIS is essential. It
 was observed that the adoption of IT systems at KI level is slow; therefore, more focus on
 capacity building and handholding support is required to enable smooth transition to IT linked
 systems.
- Accounting practices need significant improvement and capacity building for the same is essential. Orientation regarding compliance with the KVIC norms would also be helpful. Practices like payment of wages through bank, payroll management, etc. is essential.
- Efforts are required for increasing market share of khadi by the KIs and dependency on MDA and limited KVIC initiatives should be reduced. Introduction of better designs, increasing range of products and improvement in quality needs to be supported for increasing the market share.
