Sir,

Some field offices raised the query in respect of EDP training given to the Self Help Group/Co-operative Society/Trust etc. sanctioned under PMEGP Scheme that, whether all the group members are to be trained under EDP OR only the principal office bearer like Secretary of the SHG is to be trained?

In this regard, it is informed that, the query was referred to the Ministry of MSME and the Ministry vide letter No. PMEGP/EDP/1/2017 dtd. 24/25.5.2017 (copy enclosed) clarified that, "the PMEGP Application Form in respect of institutions viz. SHG, Co-operative Society, Trust etc. is filled in the name of the authorized person. This authorized person may be the Secretary of the Institution or holding any other designation as per the bylaws of the institution. The EDP training in respect of Institutions would also be given to the said authorized person or his nominee. And the EDP certificate should be issued in the name of the authorized person as follows:-

- I. If the EDP is undergone by authorized person himself; Name of authorized person, designation, name of the institution or;
- II. If EDP is under gone by the nominee of the authorized person:

 Name of person trained, Nominee of (name of the authorized person), designation of authorized person, name of the Institution.
