CIRCULAR

Sub: Exemption of EDP training to disbursed loan under PMEGP regarding.

It is to inform that Ministry of MSME has reviewed the performance of PMEGP scheme on 14th January 2019 and the proposal for exemption of EDP training to disburse the Loan under PMEGP. Accordingly the Ministry vide letter dated 16.01.2019 has conveyed the approval for exemption of EDP training to disburse loan under PMEGP till 31.03.2019. The said exemption will facilitate the financial bank to disburse the first installment of loan and claim/upload Margin Money subsidy on the PMEGP online portal without waiting for completion of EDP training and to achieve the enhance targets for the year 2018-19. All the pending EDP trainings pertaining to cases sanctioned upto 31st March 2019 shall be **completed during the first quarter of next FY 2019-20.**

2. It may please be noted that this would only be a short-term arrangement and all implementing agencies has to make all efforts to increase the output of EDP in numbers and quality. All the possible government resources (including on-line EDP already permitted by the Ministry) to complete the EDP trainings of pending and future cases in time shall be explored by the implementing agencies bank and RSETIs. During the next FY 2019-20 the BE allocation for PMEGP is likely to enhance further to Rs. 2300 cr. Hence more number of EDPs have to be conducted to achieve the targets in time.
