GUIDELINES FOR APPOINTMENT OF EXPERTS UNDER PMEGP:-

The Directorate of PMEGP has received approved action plan for BFL Funds from Ministry of MSME vide letter dated 08.09.2020 on various activities to be carried out under BFL for the year 2020-21. As per approved action plan, one technical expert, one marketing expert and two Retired Bank officials are to be engaged for each state to provide necessary guidance to the prospective entrepreneurs and also hand holding support to PMEGP beneficiaries till grounding of the unit.

In order to engage technical experts, Marketing Experts & Retired Bank officials by the State offices in a time bound manner, the following guidelines are issued: -

- 1. The appointment of the experts will be made at State level under the chairmanship of Zonal Dy.CEO for all the State Offices as per the approved budget allocation for the State/Divisional office.
- 2. A Committee for finalizing the appointment of the experts shall be constituted for each State consisting of the following officials:

a. Zonal Dy. CEO - Chairman
b. Representative of KVI Board - Member
c. Representative of SLBC - Member

d. State Director - Convenor/Member

- 3. Advertisement will be published by the respective State Offices in the leading local newspapers along with application format enabling the applicants for submission of online application before 20.10.2020 positively and same advertisement will also be uploaded on KVIC website. Draft advertisement is attached at Annexure-I.
- 4. Applications shall be received and scrutinized by the respective State Offices to initiate the selection process by 25.10.2020 positively.

- 5. After scrutiny of the applications as per the prescribed qualification and experience for each post separately, the respective State Directors will issue interview call letters to the short listed candidates by mail / post preferably before 30.10.2020 with the intimation of date for interview (to be finalized in consultation with Zonal Dy.CEOs) during the first or second week of November positively.
- 6. The said Selection committee will complete the selection process of candidates by conducting interview for each post separately. The committee shall prepare a Panel of 3 candidates for each post selected through interview.
- 7. State Director will issue appointment letters to engage technical expert, marketing expert and retired bank officials on contract basis, preferably before 15th November 2020.
- 8. The periodicity of contract for all the posts will be upto 31st March 2021 initially as per BFL Budget allocation issued to respective State Offices and it will be extended at the discretion of KVIC based on their performance, on receipt of budget sanction for the next year.
- In case, selected candidate failed to join the post within 15 days, appointment letter may be issued to the next candidate as per the panel.
- 10. Respective State Offices have to pay monthly remuneration of Rs.40,000/- P.M. as per work performance of technical & marketing experts and TA/DA will be reimbursed for official tour as per the eligibility of the post of Asst.Director-I as per GFR.

11. Respective State Offices have to pay monthly remuneration of Rs.40,000/- P.M. as per work performance retired bank officials at metro cities(Delhi, Mumbai, Kolkata, Bengaluru, Chennai and Hyderabad and @ Rs.25,000/- per month at non metro cities and TA/DA will be reimbursed for official tour as per the eligibility of the post of Asst.Director-I as per GFR.

- Experience in different Village industries, MSME, Handicrafts, Cottage etc.
- Retired officials of KVIC, KVIB, DIC, MSME DI, NSIC and COIR Board not below the rank of Assistant Director.
- Strong written and verbal communication skills of local language of the State besides official language.
- Knowledge of Machinery/Raw Material/Production process/ Identification of potential activities in the respective areas.
- Knowledge on the PMEGP Scheme, Guidelines and procedure.
