### **CIRCULAR**

**Sub.: Implementation of Online EDP Training and monitoring - Reg.**

Prime Minister's Employment Generation Programme (PMEGP) is being implemented by KVIC designated as a national nodal agency by Ministry of MSME since the year 2008. The scheme was implemented manually till the year 2015-16 and introduced the online system since the year 2016-17. Since then, the performance of the scheme is growing year by year and last 2 years, the targets have been surpassed and recorded an outstanding performance physically and financially under the scheme. To release margin money subsidy to the financing bank EDP training is one of the criteria which the beneficiary has to complete.

The EDP training is being provided by RESETI/RUDSETI, KVIC, KVIB and DIC and other States/Central Govt. training centres in offline mode in its respective training centres. Since these training centres does not have adequate capacity to provide training to the beneficiary whose loans have been sanctioned by the banks under the scheme, it become bottleneck to disburse the margin money to the Financing bank. As a result, KVIC seeks relaxation from EDP training for disbursement of margin money to achieve the target from the ministry every year. Because of this exemption, the pendency of EDP training accumulated every year and become difficult for implementing agencies to re-organise the training for these beneficiaries after disbursement of margin money.

In order to address this problem, the ministry suggested KVIC to explore the possibility to introduce online EDP training. Accordingly, KVIC has introduced online EDP training from October 2019 through the dedicated portal having all the features for the PMEGP beneficiaries including prospective beneficiaries. Thereafter, Covid-19 and subsequent lockdown were faced, and the online system introduced for EDP training become necessity and supportive in implementing programme during the pandemic period. The response for the online EDP also been overwhelming as all the physical training centres were closed.

The online EDP training system and PMEGP portal were integrated for data sharing and to generate the online certificate on completion of the training


by the beneficiaries. The agency generates the monthly invoice and submit to the Directorate of PMEGP for release of payment and Dte. of PMEGP process their payment after due validation of the beneficiary list on the MIS available on the portal.

The applications are being generated and scrutinized and forwarded to financing bank by the respective implementing agencies at field level. The bank takes credit decision and generate the margin money claim on the portal which comes to the KVIC head office directly. The offline EDP training are being organized and monitored by the field office in coordination with the respective training centres which provides checks and balance by the implementing agencies from where the application originated. Considering the view of IIM Lucknow, the present flow of information of online EDP training is henceforth disseminated to the State/ Divisional offices of KVIC for effective participation and proper check and balance of online EDP training at par with the procedure adopted for offline EDP training.

In this context, a separate module for monitoring and processing of payment for online EDP training by KVIC filed offices has been made available on the BFL portal. The online EDP training agency shall upload the training details and generate state-wise/ office-wise monthly invoice to the respective field offices for releasing the payment out of the budget provided under EDP head of B&FL on monthly basis. While releasing the payment State/ Divisional Directors shall ensure that the offline and online training should not be overlapping to avoid duplication of payment.

In view of the above, state/ divisional directors are directed to monitor the online EDP training and release payment against the online EDP completed by the beneficiaries as per MIS to the concerned agency henceforth. Divisional Directors also shall release payment towards EDP pertaining to all the Implementing Agencies under their jurisdiction for both online as well as offline EDP Training.
