CIRCULAR

Sub: Relaxation in the condition of conducting EDP training before release of loan in respect of NER States.

It is to inform that Secretary, Ministry of MSME has reviewed the performance of PMEGP scheme on 9th January 2017. Various states were lagging in their performance against the targets. There is large pendency of Margin Money claims for disbursement because of non completion of EDP training. In order to expedite the disbursement of Margin Money subsidy, it has been decided to relax the condition of conducting EDP training before release of loan in respect of North Eastern States.

- The issue of conducting online PMEGP training was also discussed and it has been decided to allow online EDP, where conducting EDP is delayed due to unavailability of full batch of 10-20 EDP persons for EDP training. The PMEGP guidelines mandates only conduct of EDP before margin money disbursement, but does not distinguish on-line mode/off-line mode.
- 2. The on-line EDP will be conducted through KVIC website for which separate guidelines are being issued.
- **3.** It is therefore requested that the above directives may be communicated to all implementing agencies, financing banks etc. for necessary action.
